To Whom It May Concern:


The Town of Mountainair is submitting an application for the FY24 Transportation Project Fund (TPF), for the Various Road/Street Improvements. These are major local service roads. The cost of the project per the Engineer's Estimate is \$5.2 Million. The requested funding would fund the entire project. The funding request for this phase is \$1,302,300 and would complete Phase 4 of this 8 phased project.

This project consists of rehab existing asphalt roadways, resurface existing gravel roads to asphalt, and construction management. This project will rebuild existing asphalt roadways, upgrade existing gravel roads to an asphalt driving surface and the pavement sections will consist of a minimum 3" of hot melt asphalt over either existing base or 4" of imported aggregate base course to existing pavement to be replaced, and will first be milled and to be used as a base course replacement during construction. This project has been designed in coordination with NMDOT Project No. 5101351 and is listed in the Top 5 of Mountainair's ICIP as Project No. 34711.

If Town of Mountainair received these funds, the project would start within 3 months, and construction is anticipated to be completed within 12 months. The town is currently under a Professional Services Agreement with Bohannon Huston Inc (BHI) specific to the project. The entire extent of the project is within locally owned right-of-way.

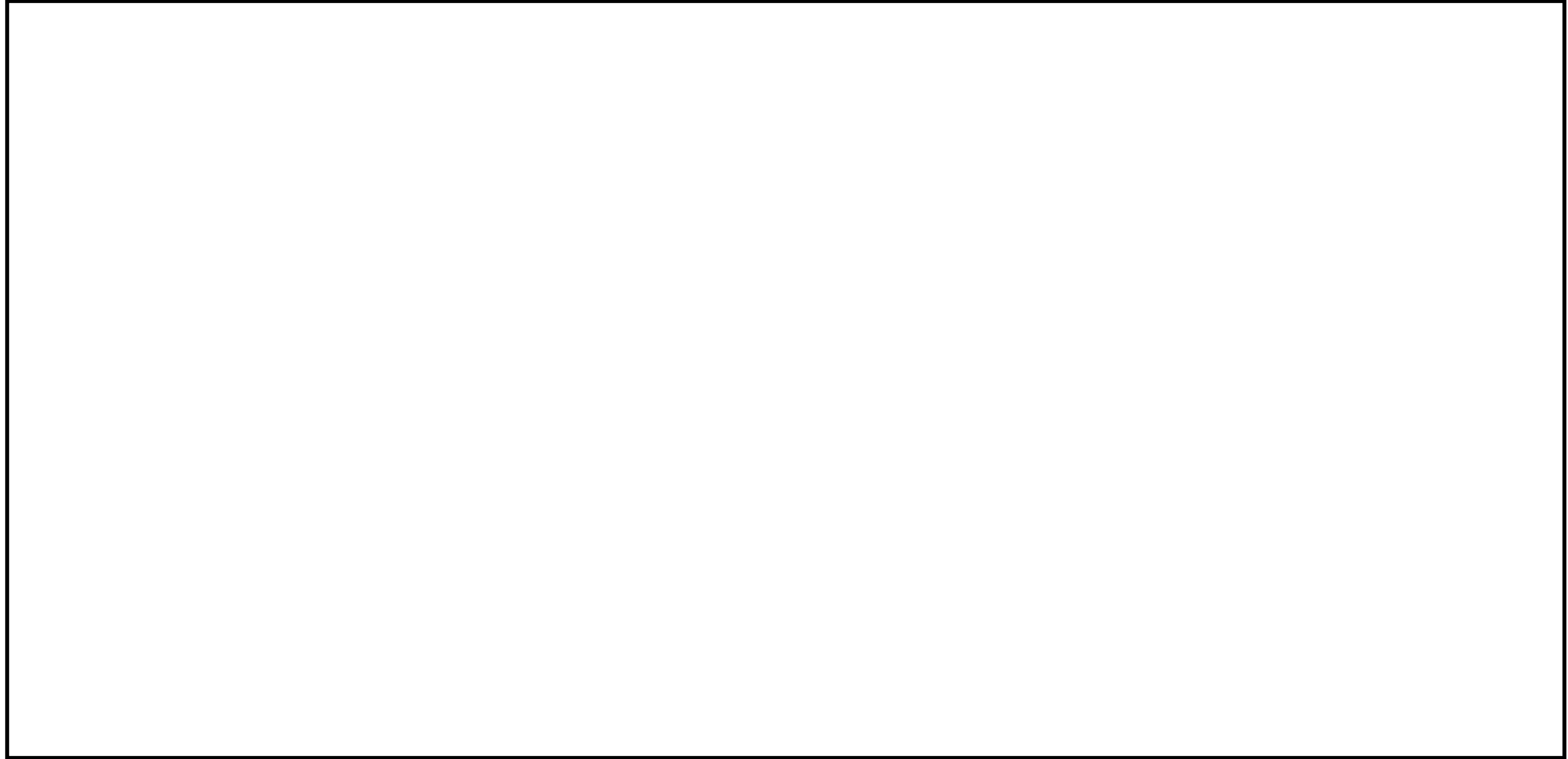

**RESOLUTION OF SPONSORSHIP FOR A  
TRANSPORTATION PROJECT FUND APPLICATION  
AND MATCH WAIVER REQUEST**

**WHEREAS,** The Town of Mountainair, New Mexico, is a municipal corporation, and has the legal authority to apply for, receive, and administer state funds; and

**WHEREAS,** The Town of Mountainair is submitting an application for Fiscal Year 2024 Transportation Project Fund in the amount of \$5,200,000;

**WHEREAS,** The Town of Mountainair intends to request a waiver for the matching fund requirement if the option is available, and;

**WHEREAS,** The Town of Mountainair agrees to pay any costs that exceed the project amount if the application is selected for funding, and;

**WHEREAS,** The Town of Mountainair intends to request a waiver for the matching fund requirement if the option is available, and The Town of Mountainair will commit to the 5% match or \$260,000 for this project if the match waiver is not available and;


**WHEREAS,** The Various Road Improvements of rehab existing asphalt roadways, resurface existing gravel roads to asphalt, and construction management, are an eligible project under the New Mexico Transportation Project Fund requirements, and;


**WHEREAS,** These roads are considered major local services roads by the Town of Mountainair, and;

**WHEREAS,** The New Mexico Department of Transportation requests, as part of the application procedure, passage, and submittal of a local government resolution of support for the project.

**THEREFORE, LET IT BE RESOLVED THAT** the Town of Mountainair supports the preparation and submittal of an application in accordance with the procedures established by the New Mexico Department of Transportation and the state of New Mexico, with Dennis Fulfer, Town Clerk to submit the application on behalf of the Town of Mountainair.
