TAB 3 Public Comments

There were no requests from the public to address the Committee.

TAB 4 Reports

❖ Staff –

Kendra Montanari, MRMPO Transportation Manager, informed the MTB that the Federal Transit Authority and Federal Highway Administration team will convene the Quadrennial Certification Review for MRMPO in May of 2022. Ms. Montanari mentioned that this upcoming review focuses on risk-based topics: Performance Measurements, New Programs under BIL, Public Engagement, Emerging

Technologies, and Transportation, Environmental Resiliency, Equity, Project Delivery. Safety will also be an emphasis area for this certification review due to the high volume of fatal accidents.

Ms. Montanari announced that MTB board member training is coming up for the March board meeting.

As a final point, Ms. Montanari introduced and welcomed the new Outreach & Engagement Planner, Peach Anderson-Tauzer.

Ms. Montanari stood for questions.

Mayor Donald Lopez, Village of Los Ranchos, asked how the Public Involvement be advertised for the Federal Certification Review. Steven Montiel, Transportation Program Manager, answered this question and stated per federal regulations, the information is posted on the MRMPO Website, and the legal notices are published in the newspaper. The information is also uploaded to all social media. As a final comment, he mentioned the potential of posting all notices in Spanish to ensure better accessibility and outreach.

❖ **TCC –**

Mr. Montiel informed the MTB that all agenda items were the same for TCC and TPTG except for Tab 8 (Election of Officers). Mr. Montiel mentioned that all action items were unanimously recommended for approval by the TPTG and TCC.

❖ **ATC –** There were no updates

❖ **CMP –**

Willy Simon, MRMPO Transportation Planner, informed that a draft of the Long Range Roadway System was ready to present to the CMP Committee members for their review. Mr. Simon also gave an update on safety trends in our region.

Mr. Simon informed that CMP accepted a scope of work from Timmons Group to update Transportation Analysis and Querying Application tool with hopes to be finalized by May or June of 2022.

Lastly, Mr. Simon mentioned that the Project Prioritization Update is still in progress to make the project submittal process more manageable and less redundant.

Mr. Simon stood for questions. There were no questions from the MTB members.

❖ **ITS –**

Nathan Masek, MRMPO Senior Transportation Planner, stated that the 2022 AMPA Regional Architecture is being reviewed for final edits and will help in project development/support for ensuring ITS project element consistency with ITS Certification requirements. Mr. Masek also stated that the AMPA Traffic Incident Management Plan was finalized.

Adopting Performance Measure #1 (PM1) Safety Targets for FFY 2022

Steven Montiel, MPO Program Manager, presented and explained the PM1 Safety Targets for FFY 2022. Mr. Montiel went through the NMDOT Safety Performance Targets and reviewed all five performance measures before the committee:

- Number of fatalities,
- Rate of fatalities per one-hundred million vehicle miles traveled (VMT),
- Number of serious injuries,
- Rate of serious injuries per one-hundred million VMT, and
- Number of non-motorized fatalities and serious injuries

Mr. Montiel stood for questions. There were no questions from the MTB members.

TAB 6 R-22-02 MTB

Adopting Public Transportation Agency Safety Plans (PTASP) developed by the City of Albuquerque Transit Department (ABQ Ride) and Rio Metro Regional Transit District

Mr. Montiel reviewed the federally required Public Transportation Safety Action Plans for Rio Metro Regional Transit District and ABQ-Ride Transit Department. He explained that the transit agencies developed these plans as part of their Safety Management System (SMS) user manuals to ensure successful implementation and operations and conformity with Title 49 Code of Federal Regulations Part 673. Mr. Montiel reviewed all plan components and highlighted the MPO coordination requirement. Mr. Montiel also stated that annual updates would be routine for the transit agencies and that plans need to be adopted by the MTB by the end of each February.

TAB 9 **Bipartisan Infrastructure Law (BIL) Update from MPO Staff**


